Subject: Witherby Publishing Group Ltd publication Licence

I refer to your request to issue a licence to publish the Merchant Shipping Legislation of the Republic of Cyprus, the Circulars, the Sanctions Information Notices (SINs) and the application forms of the Shipping Deputy Ministry to the President, which are accessible on the Shipping Deputy Ministry's website:

- a. in digital format via a USB developed by Witherby Publishing Group Ltd, and/ or
- b. through the online eBook reader developed by Witherby Publishing Group Ltd,

and I wish to inform you as follows:

2. The Shipping Deputy Ministry hereby issues a Licence to Witherby Publishing Group Ltd to publish, in digital format via a USB and/ or through an online eBook product the following (hereinafter cited together as "the Shipping Deputy Ministry's material"):

- a. The consolidated and translated into English Merchant Shipping Legislation of the Republic of Cyprus which is available on the Shipping Deputy Ministry's website;
- b. The Circulars of the Shipping Deputy Ministry that are available on the Shipping Deputy Ministry's website;
- c. The Sanctions Information Notices (SINs) of the Shipping Deputy Ministry that are available on the Shipping Deputy Ministry's website; and
- d. The application forms developed by the Shipping Deputy Ministry that are available on the Shipping Deputy Ministry's website.



3. The above Licence is issued subject to the following terms and conditions:

- a. The Licence is not exclusive, therefore the Shipping Deputy Ministry reserves the right to publish the material itself and to licence others to do so;
- b. The material shall be published as it appears on the Shipping Deputy Ministry's website and its format, content and appearance shall not be modified for any reason whatsoever without the prior written consent of the Shipping Deputy Ministry;
- c. Witherby Publishing Group Ltd shall incorporate in its USB/online ebook reader products, all updates, additions and amendments to the Shipping Deputy Ministry's material and disseminate USB updates to vessels at 2 (two) monthly intervals from the posting of such update, addition or amendment on the Shipping Deputy Ministry's website or receipt of notification to this respect by the Shipping Deputy Ministry;
- d. When issuing/ reissuing its USB/ online ebook product Witherby Publishing Group Ltd shall include therein the material with all its updates, additions and amendments and shall stipulate the following wording with respect to the USB product:

"The reproduction (or production in case of the first USB) of this USB is licensed by the Shipping Deputy Ministry to the President of the Republic of Cyprus".

- e. The assignment of the Licence is not permitted;
- f. Witherby Publishing Group Ltd shall provide, free of charge, five (5) usernames and passwords for full access to its online eBooks via Cloud Server;
- g. Witherby Publishing Group Ltd shall provide the Shipping Deputy Ministry, free of charge, one (1) copy of its USB Product and of all updates.

4. This Licence is valid for four (4) years and is subject to renewal at the request of Witherby Publishing Group Ltd. The Licence shall be automatically terminated upon breach of any of its terms or conditions.

5. The Shipping Deputy Ministry may, at any time, withdraw the Licence provided it gives Witherby Publishing Group Ltd a notice of six (6) months.

6. The Shipping Deputy Ministry may amend any of the terms and conditions of this Licence if deemed necessary and shall notify Witherby Publishing Group Ltd to this respect.
