Witherby Publishing Group Ltd – SEAMANSHIP LIBRARY

Further to your initial submission of December 2011 and the recent letter of 20 June 2016, in which you sought the views of the Maritime and Coastguard Agency (MCA) on the Witherby Publishing Group Ltd - Seamanship Library.

On the basis of our recent meeting at MCA Headquarters and the supplementary information provided, I can confirm that the MCA recognises your CD-ROM and USB-based Seamanship Library/eBook Reader and/or internet product, incorporating your electronic library of Merchant Shipping Notices and UK Statutory Instruments as electronic equivalent, enabling ship owners and operators to meet the requirements of the Merchant Shipping (Safety of Navigation) Regulations 2002, in respect of the carriage of Merchant Shipping Notices, Marine Guidance Notices and Marine Information Notices. However, vessels using the Internet version as their primary mode for access must also carry the two-monthly CD-ROM or USB memory device as back-up.

This recognition is given on the express understanding that the respective "M Notices" are reproduced by you exactly as published by the MCA, in a read-only format that cannot be altered by another party, and that the shipboard CD-ROM and/or USB device used to satisfy the carriage requirements is the latest available from your company.

The MCA also recognises the Seamanship Library as an electronic equivalent for the onboard carriage of IMO instruments such as the SOLAS, MARPOL, Load Line, COLREG and STCW Conventions and UK Regulations when these publications are required to be carried on board by the ship's Safety Management System manual. This recognition is given on the basis that: safeguards are in place to ensure correctness of their contents and prevent illegal copying; the publications incorporate the latest available amendments; and the reproduction of IMO publications complies with the terms of your IMO licence.
